### **Army, Burn Institute Surgical Research Registered Nurses**

### **United States Army (USA) Medical Training Education and Training Campus (METC) Diagnostic Medical Ultrasound Instructor**

The DMS Program provides education and training in the major disciplines of: Ultrasound Physics, Sonography of the Abdomen, Small Parts Sonography, Basic Vascular Sonography, Sonography of the Pelvis, and Obstetrical Sonography. The instructional design for the DMS Program courses is group-lock step. The program consists of lectures, group activities, demonstrations, hands-on instruction and clinical practice; instruction may include computer-based or blended learning options. Practical exercises, computerized and written examinations. Written exams and practical exercises are used to assess knowledge and skills. The goal of the DMS program is to prepare graduates to perform basic clinical diagnosis and facilitate patient care in a health care setting through the practice of medical Sonography (Ultrasound). Through didactic courses, practical exams, and clinical experience; students will acquire the professional, ethical and technical skills required of sonographers in fixed and deployable medical facilities.
