### **Air Force Invisible Wounds Interim Medical Review Panel Services**

Provides a centralized Interim Medical Review Panel (IMRP) to ensure that Total Force Airmen recognized as meeting specific IW criteria and who are pending entry into the Integrated Disability Evaluation System (IDES) process have been properly diagnosed, treated, and given an adequate course of therapy for IW conditions prior to referral to the Informal Physical Evaluation board (IPEDB).
